What We Are

The Hashgreed Domain Lifestyle Club aka Domain of Hashgreed (DoH) is the World's first mlm multi-asset tokenization community powering prime asset co-ownership among africans in a safe, secure, regulated and transparent manner using blockchain technology.

DoH is powered by **Hashgreed** - Africa's first nft marketplace, **Kross blockchain** - Nigeria's first blockchain and Africa's first smart contract enabled blockchain, **Hashgreed Domain** - World's first digital cooperative platform for tokenized and fractional assets , **Hashpay** app - Africa's first NFT mobile wallet app, and is currently **Regulated by the Lagos State Ministry of Commerce, Industry & Cooperatives as a multipurpose cooperative society** (Vinekross Royals Multipurpose Cooperative Society LSCS 18742)

Who We are

We are a community of people having an ownership and investing mindset. Every member of the Domain of Hashgreed is royalty, capable of owning a variety of assets such as Real Estate, Tech-enabled Farms, Oil Depots, Tech companies and much more. Anyone can join us stating from the Lord/Ladies Package , investing just N10,000 monthly to own properties.

How We Do It

We use tokenization and fractionalization principles on the blockchain to break down the cost of assets into several smaller affordable units or shares created on the blockchain. These units or shares are called non-fungible tokens or NFTs

for short. This allows assets to be easily owned by several people and each co-owner has the NFTs in his or her Hashpay or Hashgreed wallet and can sell his or her stake to anyone else based on the rules governing the sale of that particular NFT.

Simply put, we join funds together to own properties and we get our “digital receipt” called NFTs as proof of our ownership of those specific assets. These “digital receipts” can be easily sold, transferred, gifted to other people.

How Do We Make Money

DoH royals make money through 3 main ways. Although the best way to make better returns is having a long term attitude to the investments being owned. However below are the ways income is generated

1. DoH Tiered commission:

Royals can earn between 5 to 18% referral bonus across three referral tiers of their downlines. By building your community of co-owners, you are laying a foundation of unending passive income using the power of numbers

2. Gross Monthly Ownership Volume (GMOV) commission:

Royals also earn 2% of the Gross Monthly Volume generated for that month from the asset acquisition of their organization.

3. Leadership Bonus:

Royals get paid a one time Leadership bonus each time they attain a new leadership structure for their organization

4. Achievement Bonus:

DoH will regularly announce a target GMOV as a challenge to the esteemed royals. Those who meet the target get an Achievement bonus

5. Passive Income:

Assets acquired by our community are managed by Vinekross Technologies Limited and held by a Special Purpose Vehicle (SPV) company on behalf of the co-owners. The proceeds from net revenue by monetizing the assets are distributed to every royal based on the amount of nft shares held in that asset.

6. Asset Appreciation:

The Assets owned in our domain are mostly appreciating assets such as Real Estate or scalable companies. Assets such as music investment nfts which offer a one time fixed ROI will also be held in the domain. We make money when our assets appreciate in value due to economic factors

How Do I Get Started?

You become inducted as a royal in the Domain of Hashgreed by signing up under the person who introduced you to us, this person is called your sponsor. You can start with any package you feel comfortable with and you will be addressed with the corresponding title.

To upgrade your title, you will need to contribute the amount assigned to that title. However if at any month your contribution is below the title you started with or attained, you will assume the title of that contribution level. You can purchase any of the title packages per month, this is a no-stress community.

What Other Benefits?

DoH royals enjoy other benefits such as random free shares, enrollment in the Hashgreed discount club or other discount clubs in the ecosystem, free events for socializing, free business trainings, free tech trainings and every month, there is an NFT raffle draw where the DoH spoils the winning number with goodies.

Multi Level Organizational Structure

DoH uses a 5x5 forced matrix system . This allows for a fixed number of direct referrals and inspires team work, as your sponsor is incentivized to support your growth.

Every royal will start with the package they feel most comfortable with and will receive DoH tiered commission based on their entry or attained royalty level. However they can still enjoy the GMOV bonus which is 2% of the gross monthly ownership of their organization.

Apart from the royalty levels, the matrix structure contains leadership levels based on attained structure. These are:

Sales Rep (1)

Executive Director (6)

District Director (31)

Provincial Director (156)

National Director (781)

Senior Vice President (3,906)

The number beside these leadership positions refers to the total number of people in the organization including the leader.

Our 5x5 forced matrix will naturally progress in this way:

$$1 + 5 + 25 + 125 + 625 + 3125 = 3,906.$$

Beyond 3,906 royals in your organization, a new leadership position will be created for that pioneer.

Compensation Structure

As you most likely already know, the compensation or earning system in the Domain of Hashgreed is based on three sources, namely;

(i) Royalty Rank

(ii) Leadership Position

(iii) Asset Earnings

Let us begin with the Royalty rank:

1. Royalty Rank Commission Structure

a. Sir/Madam Package: N1k monthly investment

5% tiered Compensation:

Level 1: 3%

Level 2: 1%

Level 3: 1%

b. Honorable Package: N5k monthly Investment

5% tiered Compensation:

Level 1: 3%

Level 2: 1%

Level 3: 1%

c. Lord/Lady Package: N10k monthly Investment

5% tiered Compensation:

Level 1: 3%

Level 2: 1%

Level 3: 1%

d. Duke/Duchess Package: N50k monthly Investment

7% tiered Compensation:

Level 1: 4%

Level 2: 2%

Level 3: 1%

e. Prince/Princess Package: N100k monthly Investment

8% tiered commission:

Level 1: 5%

Level 2: 2%

Level 3: 1%

f. King/Queen Package: N1m monthly Investment

10% tiered commission:

Level 1: 7%

Level 2: 2%

Level 3: 1%

A person can invest any of these packages unlimited number of times within a month.

Now, let us describe the compensation that accompanies the Leadership position:

2. Leadership Position Compensations:

a. Gross Monthly Ownership Volume (GMOV) Bonus:

This allows a leader earn 2% of the gross amount invested for asset ownership in their organization.

b. Leadership Bonus:

This is the amount paid to a leader when they grow their organization and achieve a new leadership position. This leadership position is assigned based on three factors, namely:

- I. **GMOV**
- II. **Number of people in the organization**
- III. **Must meet a particular matrix structure requirement.**

When these three requirements are met, the royal achieves that leadership position attained.

The leadership bonus is awarded from the Executive Director position and upwards. The leadership bonus of the various positions are as follows;

Executive Director leads a team of 6 royals and a minimum Gross Monthly Ownership Volume of N100,000. Position will be conferred when minimum GMOV and 5 direct referrals are achieved. The ED has a one time leadership bonus of N10,000

District Director leads a team of 31 royals and a minimum Gross Monthly Ownership Volume of N600,000. Position will be conferred when minimum GMOV and 5 Executive Directors are achieved. The DD has a one time leadership bonus of N60,000

Provincial Director leads a team of 156 royals and a minimum Gross Monthly

Ownership Volume of N5M. Position will be conferred when minimum GMOV and 5 District Directors are achieved. The PD has a one time leadership bonus of N500,000

National Director leads a team of 781 royals and a minimum Gross Monthly Ownership Volume of N20m. Position will be conferred when minimum GMOV and 5 Provincial Directors are achieved. The ND has a one time leadership bonus of N2m

Senior Vice President leads a team of 3,906 royals and a minimum Gross Monthly Ownership Volume of N150M. Position will be conferred when minimum GMOV and 5 National Directors are achieved. The SVP has a one time leadership bonus of N15m.

c. Achievement Bonus:

DoH will regularly announce a target GMOV as a challenge to the esteemed royals. Those who meet the target get an Achievement bonus

3. Asset Earnings

These earnings are based on revenue from the asset; either monthly payouts of dividends or as a result of the asset appreciating in value over time.

a. Passive Income:

In most cases, the assets we acquire are monetized for monthly revenue or are already revenue generating assets. DoH through the Assigned Manager (Vinecross Technologies Limited or a specified managing firm) and the Special Purpose Vehicle Company will distribute monthly or quarterly dividends to participating royals of that asset. The funds will be distributed to the Kross wallet address of each co-owner via our naira stable coin or digital Naira for transparency, accounting and security reasons.

b. Asset Appreciation:

As explained earlier, majority of our assets will be appreciable assets. As time passes, assets such as real estate tend to appreciate in value. Therefore the value of our shares of the asset or nfts will also go up in price. These shares can be sold on the Hashgreed marketplace or partnering secondary markets for profit to be realized.
